GOOCHI

Your mammy gave us Saturday Detention.

THE GROUP MOVES IN TO ATTACK STING.

EXT. PUBLIC CHARTER SCHOOL - ESTABLISHING - DAY

POLICE OFFICERS, PARAMEDICS, FIREFIGHTERS AND THEIR VEHICLES ARE ON THE SCENE.

INT. PRINCIPAL'S OFFICE - SAME TIME

VICKY BUCKLER (EARLY 40S) AFRICAN AMERICAN, WEARS A SCHOOL BADGE, PROFESSIONAL ATTIRE AND A SCOWL THAT WON'T QUIT. SHE SITS AND BITES HER BOTTOM LIP.

VICKY

This could have been prevented Mr.

Mingo.

VICKY GLARES AT MR. MINGO (50S) THE PRINCIPAL, WHO SPEAKS WITH A DEEP UNCONTROLLABLE LISP.

MR. MINGO

Mrs. Buckler you know-

VICKY

I know you didn't protect my son. I told you that Grayvon threatened to do something to him.

AILEY "A" BUCKLER (LATE 40S) AFRICAN AMERICAN, HANDSOME, WRINKLES HIS BROWS.

AILEY

How you plan on handling this?

MR. MINGO

Well given the circumstances Sting
will be suspended for ten days.

VICKY

What! Nine boys and Lorena... jump my
son and he gets suspended?

MR. MINGO

I have no choice Mrs. Buckler. Your
kids-

VICKY & AILEY

Our kids!

INT. PUBLIC CHARTER SCHOOL BOY'S BATHROOM - DAY - FLASHBACK

THE KIDS CLOSE IN ON STING. THE BATHROOM DOOR FLIES OPEN. IN
RUNS STING'S SIBLINGS YOUNG KIKI(17), YOUNG SINCERE(7), AND
YOUNG CHERISH(6). THEY TAKE THE "READY" POSITION IN KARATE.

INT. PRINCIPAL'S OFFICE - DAY - BACK TO PRESENT DAY

VICKY AND AILEY LOOK AT EACH OTHER WITH RAISED BROWS. AILEY
SHAKES HIS HEAD.

AILEY

Is everybody still alive?

MR. MINGO PICKS UP A PIECE OF PAPER. HE READS WITH A HEAVY
LISP.

MR. MINGO

Yes. But we have 2 broken collar
bones, 5 busted lips, 1 broken jaw,
all 4 of them broke someone's nose.

HE LOOKS UP AT THE PARENTS WHO TRY TO HIDE THEIR LAUGHTER.

MR. MINGO (CONT'D)

6 broken ribs, 11 black eyes, and
everyone of them is concussed!

HE PUTS THE PAPER ON THE TABLE.

MR. MINGO (CONT'D)

And when I broke up the fight Sincere
did this!

HE POINTS TO HIS FRONT TEETH. AILEY LEANS BACK IN HIS SEAT.

MR. MINGO (CONT'D)

He knocked out my frontals.

AILEY SHAKES HIS HEAD FAST.

AILEY

Them's your fronts. Frontals is a
whole different thing.

VICKY

They were defending themselves. If you
suspend my children I will sue this
entire school system.

MR. MINGO

Vicky if you sue us you're fired.

VICKY

Wow. This lawsuit just keeps getting
bigger and bigger! I'll open my own
school.

MR. MINGO

You want to take our students?

VICKY

No. You can have most of them. I'm

INT. PUBLIC CHARTER SCHOOL HALLWAY - CONTINUOUS

VICKY AND AILEY BURST INTO THE HALL. THEY WALK DOWN TOWARDS
THE EXIT. A MALE JOINS THEM FROM THE RIGHT. TWO FEMALES JOIN
THEM FROM THE LEFT. THEY ALL WALK OUT.
